- 4 Attested copy Of Post Mortem Report
- 5 Certificate by the Home Branch of the Salary Package Account as per (Annexure 6)
- 6 NEFT form containing details of claimant's Account Number as per (Annexure 7) certified by claimant's Bank, for the purpose of payment in respect of settlement of claim
- 7 Cancelled cheque leaf of claimant's Bank account/ Photo copy of the first page of the claimant's Bank Pass Book containing the name of account holder, Bank account number, IFSC code
- 8 AADHAR and PAN card copy of the Claimant. If PAN card copy is not available, then form 60 to be submitted
- 9 Other suitable document to prove legal heirship in case claimant is not a nominee/ joint account holder as per Bank's record
- 10 For Armed forces, Unit Incidence Report and Internal Investigation Report / Court of Enquiry in case FIR is not available
- 11 **Additional requirement: Viscera Report / chemical analysis report in case where post mortem report shows the cause of death due to poisoning or alcohol or any substance abuse**
